#### 12:00 – 13:30 SESSION I: Scaling Up Funding and Reforming Financial Institutions Venue: CR4, UNON

This session will focus on the necessary reforms in Multilateral Development Banks (MDBs) and the enhancement of global financial liquidity through precise monetary policies, including the strategic use of Special Drawing Rights (SDRs) to maintain liquidity during critical times. Additionally, the discussion will explore required adjustments in the governance structures of International Financial Institutions (IFIs) to ensure they are more just, legitimate, and effective.
