# Mirey Atallah

*Chief of the Adaptation and Resilience Branch at UNEP's Climate Change Division* 

Mirey Atallah is Chief of the Adaptation and Resilience Branch at UNEP's Climate Change Division, leading efforts on ecosystembased adaptation, national adaptation planning, REDD+, and loss and damage. She also drives initiatives to mobilize public and private finance for climate action. With over 20 years of experience across the Arab States and Sub-Saharan Africa, particularly in Central Africa and the Congo Basin, she has worked in private industry, public administration, NGOs, and the UN.



Before UNEP, she advised the Minister of Finance in the Democratic Republic of Congo and held key roles at UN-REDD and UNDP. Mirey holds postgraduate degrees in Land Use Planning and Environmental Management.

#### Zainab Hawa Bangura

Director-General, United Nations Office at Nairobi (UNON)

Mrs. Zainab Hawa Bangura, a relentless advocate for conflict resolution and reconciliation and human rights champion, was appointed by United Nations Secretary-General António Guterres as Director-General of UNON on 30 December 2019, at the level of Under-Secretary-General.

Mrs. Bangura has over 30 years of policy, diplomatic and practical experience in the fields of governance, elections, corruption, gender, international cooperation and relations, peace operations, and conflict resolution and reconciliation.



Before joining UNON, Mrs. Bangura was United Nations Under Secretary-General and Special Representative of the Secretary-General on Sexual Violence in Conflict from 2012 to 2017. She served as Minister of Health and Sanitation (2010 to 2012) for the Government of Sierra Leone and was previously Minister of Foreign Affairs and International Cooperation (2007 to 2010).

Mrs. Bangura began her United Nations career with on-the-ground experience in peacekeeping operations in the United Nations Mission in Liberia (UNMIL), where she was responsible for management of the largest civilian component of the Mission, including promoting capacity-building of government institutions and community reconciliation.

As a Minister in the Government of Sierra Leone, Mrs. Bangura was instrumental in developing national programmes on affordable health, advocating for the elimination of genital mutilation, managing the country's Peace-Building Commission and contributing to multilateral and bilateral relations with the international community. She has deep experience engaging with State and non-State actors on issues relevant to sexual violence, including engaging with rebel groups.

Mrs. Bangura has been globally acclaimed for her achievements as a civil society, human and women's rights campaigner and democracy activist, notably as Executive Director of the National Accountability Group, as well as Coordinator and Co-founder of the Campaign for Good Governance. Nominated as one of the 100 most Influential Africans, Mrs. Bangura has been the

recipient of many awards, including the IHL Dialogs – Joshua Heinz Award for Humanitarian Achievement, the Human Rights Award from the Lawyers Committee for Human Rights, the National Endowment for Democracy's Award, the African American Institute's Distinguished Alumna Award, the Hillary Rodham Clinton Award for Advancing Women in Peace and Security from Georgetown University, and the Harvard School of Public Health, Kennedy School of Government award for Harvard 2012 Health Leader.

Mrs. Bangura is a former fellow of the Chartered Insurance Institute of London, possessing Diplomas in Insurance Management from the City University Business School of London and Nottingham University, and a Bachelor of Arts degree from Fourah Bay College, University of Sierra Leone. She also holds Honorary Doctorates in Law (from Syracuse University, USA 2019, Aberdeen University, UK 2015, Oxford Brookes University, UK 2015, Ursini College, USA 2014) and an Honorary Doctorate in Humane Letters (Florida Atlantic University, USA 2015).

## Francesc Pont Casellas

Francesc currently heads the International Economy and G20 Unit at the Office of the Prime Minister of Spain, where he leads on bilateral and multilateral economic issues and EU economic affairs. Francesc also leads and coordinates Spain's overall participation in the G20, as its Sous-Sherpa, since 2020. Before joining the Prime Minister's Office, Francesc worked for over six years at the Council of the European Union, where he held various roles in EU foreign, security and defence policy, including as a direct senior advisor to the Director-General for Foreign Affairs and various policy leadership roles on legislative and non-legislative files.



He holds a Master's degree in European Integration, a Postgraduate degree in Political Analysis, and two Bachelor's degrees in Advertising and Public Relations, and in Translation and Interpreting – including study periods in various European universities, America and Asia.

She has been Ambassador to Ivory Coast and to Senegal and has served as Deputy Head of Mission in Pakistan and Kenya and as Counselor in the Permanent Mission of Spain to the United Nations and International Organisations in Geneva.



In the Ministry of Foreign Affairs, Ms. Díaz has been working in the Departments of the Midlle East, Subsaharan Africa and in the Diplomatic Information Office. While posted in Madrid, she has also held different positions in the Spanish Agency for International Development Cooperation, including that of Director for Cooperation with Africa and Asia.

# Obiageli "Oby" Katryn Ezekwesili

# *President of Human Capital Africa (HCA) and Founder of School of Politics, Policy, and Governance (SPPG)*

Obiageli "Oby" Katryn Ezekwesili is the Founder of SPPG - School of Politics, Policy and Governance which is spreading across Africa as an unconventional and replicable franchise model for public leadership development to tackle Africa's governance problems. She is also the President of Human Capital Africa addressing the "learning crisis" among African children in foundational levels of education. She was a candidate for office of the President of Nigeria in the 2019 election and became the Founder- Chairperson of #FixPolitics Initiative a research-based citizens led initiative. FixPolitics envisions "A country where



politics is inclusive, the needs of citizens are prioritized, democratic principles are respected, such that good governance is the norm". Ezekwesili is also a co-founder of Transparency International - the Berlin-based global anti-corruption body and was one of the pioneer directors of its Board from 1994-1999.

Ezekwesili was a Vice President of World Bank- Africa Region in Washington DC between 2007 and 2012. She served in the Government of Nigeria between 2000 and 2007. She was the Minister of Minerals and later of Education. She was a presidential aide and headed the Budget Monitoring and Price Intelligence Unit which later became the Bureau for Public Procurement- BPP. She was concurrently the pioneer Chairperson of the Nigerian Extractive Industry and Transparency Initiative - NEITI in which capacity she successfully designed and implemented the global principles for Nigeria.

Ezekwesili also worked as the Director of the Harvard-Nigeria Economic Strategy Project at the Center for International Development at the Kennedy School of Government, Massachusetts. A Chartered Accountant and Consultant; She holds an MA in International Law and Diplomacy, an MA in Public Policy and Administration from the Kennedy School of Government, Harvard University. She's an honorary Doctor of Science degree, Federal University of Agriculture, Abeokuta Nigeria and in 2016 the University of Essex Business School awarded her an honorary Doctorate Degree in Business in recognition of her role in promoting economic and social justice in African countries. Ezekwesili was recognized as one of Time-100 Most Influential People and by New York Times as one of the 25 Women of Impact, 2015. Albert Einstein Foundations named her one of 100 visionaries featured in the 3D book "Genius:100 Visions of the Future." Ezekwesili was a Richard von Weizsäcker Fellow at the Robert Bosch Academy in Berlin Germany between 2019 and 2020.

She has received numerous awards and on boards of numerous local and international organizations such as; Board of Trustees, the International Bureau of Fiscal Documentation (IBFD); Honorary Member, Committee of the Crans Montana African Women's Forum; Board of Director of the Economic Policy Think Tank, AfriHeritage; Ambassador, International IDEA; Member of the Global Advisory Board for Facebook's Community Leadership Program; Global Board of Governors, NCMG International; Member of the UN Refugee Agency (UNHCR)'s Advisory Group on Gender, Forced Displacement and Protection; Member of the Advisory Board of the Atlantic Dialogues; Independent Director, Board of Bharti Airtel India; Member of Board, Tufts University-Global Leadership Center Boston; International Advisory Board, Tel Aviv University Hartog School of Public Policy, Tel Aviv, Israel; Central European University-School of Public Policy, Budapest Hungary; Global Board, WWF Switzerland; Commissioner, Global Ocean Commission - United Kingdom; IC Publications; Democracy Ambassador - International IDEA and several others. The PRIO- Peace Research Institute Oslo listed her as one of potential candidates for the 2018

Nobel Peace Prize. She was decorated with the national award of Commander of the Order of the Federal Republic (CFR) by her country and was selected as a 2020 Global Leadership Awards Honoree by Vital Voices for her leadership role in the fields of human rights, economic empowerment and political reform.

Ezekwesili is the current Board Chair, Women Political Leaders (WPL), Brussels – Belgium, she was a Senior Fellow at Yale Jackson Institute for Global Affairs, USA and was also a Richard von Weizsäcker Fellow at the Robert Bosch Academy in Berlin Germany. She is a globally renown Speaker and contributor to numerous studies and publications on Economic Policy, Transparency, Accountability and Governance, Human Capital Development and Africa Economic prospects.

Nilanjan was the President of the Indian Society for Ecological Economics (INSEE, 2022-24) and the Director of the Think20 India Secretariat during India's G20 Presidency in 2023. He was also a Member of the Expert Committee constituted by the Supreme Court of India in 2021, formulating the Net Present Value criteria for forest land diversion.

Nilanjan has taught at institutions including Linnaeus University (Sweden), the Indian Institute of Management Calcutta, and Jadavpur University, and visited Uppsala University, Massachusetts Institute of Technology, and Stanford University. A natural resource economist with over two decades of experience, Nilanjan holds a Ph.D. from the Indian Institute of Management Calcutta. He has authored/ edited 15 books and monographs and has written over 100 peer-reviewed papers and several commentaries/ op-eds. His advisory work spans organisations like IUCN, USAID, FORMAS, UNCTAD-India, WWF-UK, IWMI-WLE, etc.

In 2024, Dr Leon was appointed Ambassador-at-Large for the Government of Saint Lucia, focusing on development finance and SIDS-related issues.



Dr Leon served as the sixth President of the Caribbean Development Bank (CDB), the regional development finance institution based in Barbados, where he championed a systems approach to economic development based on the notion of social justice. With over 30 years of experience in economic development, Dr. Leon has directed macroeconomic and financial policy support to government authorities in Africa, the Middle East, Central Asia, and the Caribbean. A former Associate Professor, Dr. Leon worked with the International Monetary Fund (IMF) for more than 24 years, functioning as Mission Chief in parts of Africa, The Bahamas, and several Gulf States, as well as IMF Senior Resident Representative in Jamaica and Nigeria. Dr. Leon also served as Director of Research at the Central Bank of Barbados and was Country Economist at CDB.

Nathaniel is championing for the inclusion of youth in political, social, and economic processes. Through the Political Parties Liaison Committee (PPLC), he lobbied for the amendment of Kenya's Political Parties Act 2011 to increase the nomination of youths to Kenya's Parliament and County Assembles.

Academically, Nathaniel holds Master of Arts in Project Planning and Management (PPM) from the University of Nairobi. He also graduated with a Bachelor of Science Degree in Strategic Management from Moi University. Professionally, Nathaniel completed Section 6 of the Certified Securities and Investments Analysts (CSIA) from Kenya Accountants and Secretaries Examinations Board (KASNEB).

In 2022 General Elections, he ran for Member of Parliament for North Mugirango Constituency, in Nyamira County and emerged first runners up in a hotly contested parliamentary elections. Among the key nationalistic issues Nathaniel focuses on is the amendment of the Tea Act to create fair conditions for the tea farmers from Nyamira County. Enhancement of value addition of agricultural value chains specially to create jobs for the young people. He represented Kenya and Global South in COP28 Dubai as a panelist in the topic of "climate financing and what a just transition means for the Global South."

Nathaniel has ambitions for higher political offices in the future. He currently works with Kenya's Prime Cabinet Secretary and Cabinet Secretary for Foreign and Diaspora Affairs Musalia Mudavadi. He deals with Strategic Projects.

# Musalia Mudavadi

EGH Prime Cabinet Secretary and Minister for Foreign and Diaspora Affairs Government of Kenya

Wycliffe Musalia Mudavadi, born on September 21, 1960, in Sabatia, Vihiga County, Kenya, is a seasoned politician and land economist currently serving as Kenya's Prime Cabinet Secretary and Minister for Foreign and Diaspora Affairs. He assumed the role of Prime Cabinet Secretary on October 27, 2022, marking a significant milestone as the first individual to hold this position in Kenyan history. In 2023, his portfolio expanded to include responsibilities as the Cabinet Secretary for Foreign and Diaspora Affairs.



Mudavadi's political career spans several decades, commencing in 1989 when he was elected unopposed as the Member of Parliament for Sabatia Constituency, succeeding his late father, Moses Mudavadi. He retained this seat through subsequent elections in 1992, 1997, and 2007. His ministerial appointments have been diverse, including roles such as Minister of Supplies and Marketing, Minister of Finance, Minister of Agriculture, and Minister of Transport and Communications. Notably, he served as Kenya's seventh Vice President in 2002 and as Deputy Prime Minister from 2008 to 2012.

Educationally, Mudavadi attended Nairobi Primary School, proceeded to Jamhuri High School and Nairobi School for his secondary education, and later earned a Bachelor of Arts degree in Land Economics from the University of Nairobi. Beyond his political endeavors, he is an enthusiast of sports, having played rugby during his school years, and is a fan of Manchester United Football Club and AFC Leopards. In 2019, he published his autobiography, "Soaring Above the Storms of Passion," offering insights into his life and career.

# Chenai C. Mukumba

# Executive Director, Tax Justice Network Africa

Chenai Mukumba is the Executive Director at the Tax Justice Network Africa (TJNA). She is based in Nairobi, Kenya and overall provides strategic leadership and direction to deliver on TJNA's mission and vision in its various thematic areas. Chenai has a master's in International Relations from Wits University, Johannesburg and a master's in Taxation from the University of Oxford.

Tax Justice Network Africa (TJNA) is a research and advocacy organisation with a robust network of civil society organisations with the united effort of leading tax justice voices across the continent. Through its Nairobi Secretariat, TJNA



collaborates closely with its member civil society organisations to curb illicit financial flows (IFFs) and promote progressive taxation systems. In partnership and collaboration with other regional economic governance institutions, TJNA advocates for tax policies with pro-poor outcomes and tax systems that curb public resource leakages and enhance domestic resource mobilisation. TJNA's vision is to see a new Africa where tax justice prevails and ensures equitable, inclusive, and sustainable development.

# Dr. James Mwangi

# CBS Group Managing Director and CEO, Equity Group Holdings Plc. Executive Chairman, Equity Group Foundation

Dr. James Mwangi is one of Africa's most renowned thought leaders, a disruptive entrepreneur and philanthropist. As a champion of financial inclusion, James is credited with democratizing financial access, by removing entry barriers in Kenya and the region. As a disruptive and turnaround leader, he pioneered a savings led microfinance revolution giving the largely excluded majority of un-banked households, businesses, enterprises, and communities in the country the opportunity for broader economic participation.



Under his leadership, Equity has made investments in technology and innovation accelerating growth across Africa building a client base of over 16 million in 6 countries (Kenya, Tanzania, Rwanda, South Sudan, Democratic Republic of Congo, and Uganda) with a representative office in Ethiopia, and a total asset base of over USD 14 billion. Equity Group has one of the most extensive physical and digital distribution networks in the region with millions leveraging electronic, cards, mobile, and internet self service capabilities.

Driven by the commitment to scale up shared prosperity and social impact interventions that transform lives and livelihoods, James initiated the establishment of Equity Group Foundation (EGF), the social engine of Equity Group, in 2008. EGF implements innovative programs that leverage on the infrastructure of the bank achieving a higher social return on investment. While serving as the Executive Chairman, he has shaped notable EGF programs and mobilized the support of like-minded partners to commit USD 690 million for social impact. Under the Education and Leadership Development pillar, EGF has offered 60,000+ secondary school scholarships to academically gifted but socioeconomically challenged children. James serves as a lead mentor and coach to the youth and is committed to their transition to tertiary education, where they join the Equity Leadership Program of 23,825 scholars who have joined university, with 970 having joined leading global learning institutions.

Based on his vast experience in both social impact and entrepreneurship, James has had an opportunity to provide thought leadership on several global platforms. ## Attiya Waris

United Nations Independent Expert on Foreign Debt, Other International Financial Obligations, and Human Rights

Attiya Waris is Kenya's second full female law professor and the first professor from a religious, ethnic and racial minority in the country. She is also the only known Professor of Fiscal law on the African continent. Her original scholarly contribution to this field has been the development and strengthening of the linkages between finance and development through taxation, debt and illicit financial flows and the raising of living standards.



Professor Waris has in the past held the position of Director Research for the University as well as acting Deputy Principal College of Humanities and Social Sciences as the first female Professor to hold both posts separately and simultaneously. She holds several portfolios currently and: is currently serving as the UN independent expert on foreign debt and international financial obligations under implications for human rights globally, a member of the International Tax Taskforce on Climate and Development, the Chair of the Supervisory Board of the Capabuild Foundation based in the Netherlands, a Commissioner on the O'Neill-Lancet Commission on Racism and Structural Discrimination and Global Health and a member of the Editorial board of the Yearbook on Economic Determinants at the WHO a member of the Working Group on Debt at the Madrid Club as well as the Managing Editor of the Journal on Financing for Development housed at the University of Nairobi. Most recently Professor Waris was quoted in May 2024 by President Higgins of Ireland in his keynote speech in Dublin, Ireland, in the Constitutional Court of Kenya in October 2023 during the debate on housing tax. In addition, her work was cited by the Minister of Foreign Affairs Frederick Mitchell of the Bahamas in his intervention during the recently concluded G77 meeting in Kampala in January 2024. She has been a founding member of several organisations including the African Tax Researcher's Network based in South Africa, the Tax Justice Network Africa, the Capabuild Foundation in Amsterdam and the Committee of Fiscal studies, University of Nairobi and most recently AFRODAD-East and Horn of Africa and the House of Fiscal Wisdom (a new thinktank based in in Nairobi focussing on the International Fiscal Architecture).
